Call to Order

The Trustees of the Hale High School Fund met via Zoom conference call on February 4, 2021. Jeff called the meeting to order at 2:37 p.m. All Trustees were present.

Annual Report

Trustees reviewed the narrative of the HHSF report to be printed in the 2020 Town Report. The report includes a brief history of the HHSF and a summary of how recent grants to the Randall Library have been used. The report highlights the recent decision by the HHSF Trustees to change investment managers and the resulting savings to the HHSF and to the Town of Stow.

The report will also include a financial summary for the 2020 Fiscal Year. (July 2019 through June 2020). Since the investment manager change occurred during this period, the financials will be presented in two parts: information from Green Savings from July 1, 2019 until assets were transferred to Bartholomew and Company and then information from Bartholomew and Company for the second half of the fiscal year.

Jeff will forward financial information to Town Administrator's assistant as soon as he receives it.

Disbursement to Randall Library Follow Up

Randall Library Truste's treasurer has requested that future disbursements be deposited into the Randall Library Trust's checking account. Jeff has contacted Bartholomew and Company to clarify the preferred process for future disbursements.
